Dear Ms Andersson

We address you as one of the non-government organisations in Namibia that are supported by Afrikagrupperna (AGS).

The Legal Assistance Centre (LAC) is a public interest law firm in Namibia, the only of its' kind. It was established in 1988 before independence in an effort to counter the atrocities then committed during the independence movement. Sweden was a strong supporter of the Namibian independence movement and in fact provided continued support to Namibia thereafter.

Namibia is a democracy that it is still finding its feet. Our current government comes from the members of the freedom fighters and have, respectfully, grown out of touch with the people of Namibia. Dilapidated hospitals, sub-standard education, growing informal settlements and 50% unemployed youth gives an indicator of the challenging progress of the new Namibia. The youth are becoming impatient.

It is within this context that civil society, such as the LAC, is necessary. In essence we have been termed an opposition party. We do not just hold the government to account in assisting constituents but also support them where we can with providing input to legislation and policy. In this context, advocacy also plays a very important part in our efforts. While we have dedicated projects these do not define the only work we do.

The World Bank considers Namibia as an "upper middle income country". The reality is that we have one of the highest inequality levels in the world second only to South Africa in terms of the ginicoefficient.

The World Bank's definition has resulted in many countries no longer funding NGOs in Namibia. While this is understandable since there has to be a bottom line, it has meant even more hardship for the ordinary Namibian than before.
